Workers' Compensation – Statute of Limitation** - Consideration of a Draft Final Report proposing modifications to clarify the statute of limitations in Workers Compensation actions (N.J.S. 34:15-15 and N.J.S. 34:15-51) as discussed in *Plastic Surgery Center, P.A., v. Malouf Chevrolet-Cadillac, Inc.*, 241 N.J. 11 (2020). [Report](#)
