1. **Autobus** - Consideration of a Draft Tentative Report proposing modifications to N.J.S. 54:39-112(a)(1) and N.J.S. 54:15B-2.1 to clarify the use of the term “autobus” as discussed in *Senior Citizens United Community Services, Inc. v. Director, Division of Taxation*, 32 N.J. Tax 381, 385 (2021). [Report](#)
